Awareness and Assumption of Risk

I am aware that hiking, snowshoeing, skiing, and any other outdoor activity involve risk, including but not limited to personal injury, illness, or death arising from rough or uneven terrain, floods, rockfall, snow or ice, weather, remoteness, wild animals, obstructions, equipment, including property damage, expense and related loss, and loss of income. Risks also included are negligence on the part of the University of British Columbia, the Faculty Women's Club, its Directors, Officers, Officials, Volunteers, and Other Participants (hereinafter collectively referred to as "the Releasees").

I freely accept and fully assume such risks associated with such outdoor activities, including the failure of organizers and volunteers to take reasonable steps to safeguard or protect me from such risks. In entering into this Agreement I am not relying upon any oral or written representations made by the Releasees with respect to the safety of such outdoor activities other than what is set forth in this Agreement.

Waiver of Claims, Release of Liability, and Indemnity Agreement

In consideration of the Faculty Women's Club accepting my application to participate in hiking, snowshoeing, skiing, and/or any other outdoor interest groups and activities, I agree:

- To waive any and all claims that I may have in the future against the Releasees; and
- To release the Releasees from any and all liability for any personal injury, death, property damage, expense and related loss, including loss of income, that I may suffer as a result of my participation in such activity or activities, due to any cause whatsoever, including negligence, breach of contract, or breach of any statutory duty of care; and
- To hold harmless and indemnify the Releasees from any and all liability for any damage to property of, or personal injury to, any third party, resulting from my participation in such activity or activities.

This Document shall be governed solely by the laws of British Columbia and no other jurisdiction. Any litigation arising between the Participant and the Releasees shall be brought solely within the Province of British Columbia and shall be within the exclusive jurisdiction of the courts of British Columbia.

I HAVE READ THIS DOCUMENT, FULLY UNDERSTAND IT, AND AGREE TO BE BOUND BY ITS TERMS. I AM AWARE THAT IT IS A LEGAL DOCUMENT. I AM FURTHER AWARE THAT BY SIGNING IT I AM WAIVING CERTAIN RIGHTS WHICH I MIGHT OTHERWISE HAVE AGAINST THE RELEASEES.
